TITLE: Reducing the average number of days to start a tissue audit decreases the average number of days to send a chart to the tissue processor.

BACKGROUND:

Southwest Transplant Alliance (STA) is an OPO and Tissue Bank. STA works with seven Tissue processors and recovers Musculoskeletal, Dermis and Cardiovascular Tissue. In 2022 STA recovered 705 tissue donors. STA has seen a 25.2% increase in the number of tissue donors recovered. These lifesaving/life enhancing grafts totaled more than 10,000.

STA does a 100% audit of the Tissue charts.

In September 2022 due to the increased volume of tissue recovered, the STA Quality team experienced an increase in the number of days to perform a tissue chart audit from 2.62 to 3.19. This created a backlog in the number of days to begin an audit, auditor burn out, and the supervisor spent more time on tissue chart auditing. In addition, the additional tasks that a chart auditor was performing in addition to auditing such as: requesting autopsy information, medical records, cultures etc. was taking away from auditing time.

To counter this, permission was obtained for an additional chart auditor. Adding an additional auditor will aid in fewer days to begin a tissue chart audit and quicker tissue chart audit completion, leading to obtaining release for transplantation quicker.

HYPOTHESIS: Adding an additional auditor along with a hybrid auditor/medical records specialist dedicated to obtaining medical records and autopsy reports will reduce the number of days it takes to audit a tissue chart.

METHODS: September 2022 two additional positions to the auditing team were acquired. One position to audit tissue charts and one position obtains all medical records and autopsy reports in addition to performing tissue chart audits.

CONCLUSIONS: Numbers went up during the training period between September 2022 and December 2022 but levelled off to an average of 2.3 days to begin an audit, which is below the beginning number of days to begin an audit of 2.62.
